## ECIA Leads Industry-Wide Design Registration Initiative



ECIA's Global Industry Practices Committee (GIPC) has taken on the task of modernizing the channel's design registration process. Assembling a group of Subject Matter Experts (SMEs) and industry stakeholders, representing the authorized component channel, to include semiconductors, passives and

electromechanical/interconnect, the group will approach the project with a multi-phase initiative to assess the current state and what the future state might look like.

"The initiative was proposed by ECIA's Manufacturers' Council," explained Don Elario, ECIA Vice President of Industry Practices, "it will bring representatives from all the component technology sectors together. In addition to participation from each of the three ECIA Councils, there is representation from GEDA (Global Electronics Distribution Association) and ERA (Electronics Representatives Association). This is a longstanding process in the industry and modernization is a likely next step."

#### Weekly Economic Trends National Association of Manufacturers

By special agreement ECIA is pleased to present NAM Chief Economist Chad Moutray's weekly analysis of key U.S. government economic data and manufacturing industry trends in the <u>NAM Economic</u> <u>Report - June 22.</u> Exposure to COVID-19 is considered a workplace hazard for purposes of OSHA compliance. As such, employers should be cognizant of the application of existing OSHA requirements to the prevention of occupational exposure to COVID-19. In general, these regulations require the use of personal protective equipment (PPE) when job hazards warrant it. OSHA has resource (https://www.osha.gov/SLTC/covidprovided а 19/hazardrecognition.html) to assist employers in assessing the risk of exposure to employees. More recently, the agency has published FAQs (https://www.osha.gov/SLTC/covid-19/covid-19fag.html#cloth-face-coverings) on wearing masks while at work. While employers may require employees to wear masks at work, the employer is not required to provide masks. However, it should be noted that cloth face masks are not considered PPE.

## June TPC Covid-19 Survey Report



As a follow up to their ongoing research on the impact to the electronics supply chain in China from the Coronavirus (COVID 19); TPC conducted a 4th special survey. The survey had roughly 6,700 respondents with +/- 85% located in China.

Some key findings include:

- Roughly 85% of the respondents see production down only 5% or less for C2Q due to the virus' impact
- Now 37% think the production shortfall in C1Q will be made up in C2Q while 59% believe it will be made up in C3Q
- Less than 1% are saying the production shortfall will never be fully made up versus 15% in the April survey
