ECIA's Don Elario on the GIPC: Managing through Tariffs



China tariffs have now been with us for more than a year and disruption continues throughout the global supply chain. The GIPC (Global Industry Practices Committee) has a special working group looking into how to best manage tariff's during this difficult period.

This work group is made up of SME's (Subject Matter Experts) from both distribution and manufacturing and are focused in the following areas:

- 1. Establishing a best practice document highlighting ways to handle tariffs between supply chain partners. A document was published in January 2019 and is available to all ECIA members.
- 2. Thinking ahead and preparing for the day when tariffs are removed. To that end, the working group is currently engaged in:
 - Creating a tariff checklist with items each company should be aware of and applying necessary actions steps applicable to their circumstances
 - Outlining flowcharts for best practice guidance on selected processes, i.e. an example being Drawbacks
 - Preparing a guidance summary document

This work is well underway to help ECIA member companies navigate the unwinding process of tariffs and scheduled to be completed and published at the end of Q3.
