Government Provides Three Lists of Tariff Exclusions

The Office of the U.S. Trade Representative on September 20th announced three lists of products excluded from tariffs manufactured in China. The exclusion includes a number of electronic components, including capacitors, switches and connectors.

The announcements, published in the Federal Register, 84 FR 49564, 84 FR 49591 and 84 FR 49600, stated that exclusions are available for any product that meets the description set forth in the Annexes if the product falls within the scope of the product descriptions set forth in the Annexes. The exclusion applies retroactively to goods entered for consumption, or withdrawn from a warehouse for consumption, when the tariffs went into effective, with the earliest list being July 6, 2018.
